Old Business

Minutes from the October board meeting were reviewed and approved.

Issues Reviewed:

- **Entrance Sign:** The Seneca Ridge sign was thoroughly researched and is no on hold due to the fact that the sign must be erected on SR property.
- **Highlights of the Year:** Joe Cyrulik shared Seneca Ridge highlights of the year and thanked all the current board members for their service.

 3. He has the correct dog curbing signage and plans this upcoming weekend to replace those that were stolen.
 4. The mowing from this week was done when the ground was still too saturated from the rain. The mowers therefore deeply rutted common areas in the low section just off the cul de sac of Trail Ridge Ct. Ron is researching getting this problem corrected.
- **ARC Submissions:** Bob Sherfy has been handling this position, and there have been no issues of concern.
 - **Treasurers Report:** Mark Laing reported the following:
 1. We now have only TWO outstanding debtors! Good Job, Mark! It was decided to delay further action on pushing collection to coincide with the new billing cycle, which will begin January 31st, 2003.
 2. It was moved and approved that the board pay \$40 to have dues billing envelopes stuffed for mailing.
 3. Discussion was held as to whether the new directory, when printed, should be mailed or hand delivered.
 4. Mark agreed to research the cost of doing a mailing to insure all residents get a copy.
